**SUPPLY OF COAL 2,250,000 MT ± 10% (Term Tender Index Based, 180 days Credit) FOR LAKVIJAYA  
POWER PLANT**

The Chairman, Special Standing Cabinet Appointed Procurement Committee (hereinafter referred to as "SSCAPC") of Ministry of Power and Energy invites bids for the supply of coal for the 900MW Lakvijaya Coal Power Plant (the Plant) from prospective coal suppliers (Local or International) who wish to submit a Bid and LCC Registered Coal Suppliers. This invitation is extended by the Lanka Coal Company (Private) Limited (hereinafter referred to as "LCC") on behalf of SSCAPC.

1. Procurement method will be international competitive bidding (ICB).
2. Contract period is from October 2022 to April 2024.
3. Estimated quantity of coal to be supplied to Lakvijaya Plant is 2,250,000 MT±10% .
4. CFR Price should be quoted in USD or LKR with a minimum of 180 days credit facility to be provided by the bidder.
5. Amount of Bid Security is USD 2 million or LKR 750 million and shall be valid up to 120 days from the closing of the tender.
6. Deadline of bid submission is 10.00 a.m. (Sri Lanka Standard Time) on **25<sup>th</sup> October 2022**.
7. Minimum eligibility criteria for prospective bidders are, company should be registered more than 3 years, minimum of 1 million MT of coal should be supplied within last 3 consecutive years having Gross Calorific Value of above 5900 kCal, annual average turnover USD 50 million per year for last 3 consecutive financial years, and other criteria should be as per the bidding document.
8. A complete set of Bidding Document can be obtained by paying USD 700.00 or LKR. 250,000.00 as nonrefundable charges by interested applicants on submission of a written request with **cash deposited receipt** or **Telegraphic Transfer (TT) receipt** to LCC between 09.00 AM to 04.00 PM (Sri Lanka Standard Time) from 03<sup>rd</sup> October 2022 to 24<sup>th</sup> October 2022, during working days from **Lanka Coal Company (Private) Limited, 51/3, Suranimala Place, Off-Dutugemunu Street, Kohuwala/Dehiwala 10350, Sri Lanka.**
