Scope of activities includes, Supply of 50nos electric battery buses, Payment on Per kilometre rate basis which shall including Installation of charging Infrastructure, maintenance and charging of buses for the daily deployment of Sri Lanka Transport Board in Colombo and Suburbans.

All activities shall be carried out complying with the relevant Industrial and environmental standards applicable for battery electric bus operations.
