### AUGMENTATION OF JAFFNA INTERNATIONAL AIRPORT, SRI LANKA

The Cabinet Appointed Negotiation Committee (CANC) is inviting proposals on behalf of Airport & Aviation Services (Sri Lanka) (Private) Ltd. for the Augmentation of Jaffna International Airport, Sri Lanka. The objective is to enable the operation of Wide-bodied aircraft (specifically designed aircraft of A330) through the mode of Design, Build, Finance, Operate, and Transfer (DBFOT). Interested parties are required to fulfill the following minimum requirements and make their capital investment:

- (a) An average annual turnover over of the immediate past five (5) years to the value of at least United State Dollars Fifty Million (USD 50,000,000) or equivalent in any other currency at the date of opening of EOI.
- (b) The interested party shall have sufficient (at least equal to project cost) bank credit line facilities for the completion of the construction works as proof of Credit.
- (c) The Interested party shall have an audited balance sheet with minimum United State Dollars Twenty Million (USD 20,000,000) of net assets for the latest financial year.
- (d) Litigation history if any of the Interested parties shall be declared.

Submission of proposals is open to firms and Joint Ventures of any nationality. In the case of Joint Ventures, all parties to the Joint Venture shall be jointly and severally liable for the entire work.

The EOI Document in English Language can be purchased from 19 February 2024 between **09.00 hrs. to 15.00 hrs** on working days **up to 01 April 2024** from the **Supply Chain Management Division, Airport & Aviation Services (Sri Lanka) (Private) Limited, Bandaranaike International Airport, Katunayake, Sri Lanka** on payment of a non-refundable fee equivalent to US Dollars 500 in Sri Lankan Rupees (LKR 160,000). In addition, the document can be downloaded from the web <u>www.airport.lk</u> making an online payment of US Dollars 500. EOI documents can be inspected free of charge at the above address and website. However, proposals should be submitted on EOI documents purchased by the relevant party.

Proposals will be closed at **14.00 hrs. on 03 April 2024** and will be opened immediately thereafter in the presence of the Proponent or their authorized representatives at the Aviation Division, Ministry of Ports, Shipping and Aviation, Level 30, West Tower, World Trade Center, Colombo 01, Sri Lanka.

Completed Proposals shall be sent to the address above not later than **14.00 hrs. on 03 April 2024.** Late submissions will be rejected and returned unopened.

Proponents or their designated Representatives are invited to attend the **Pre-Proposal Meeting at 1330 h on 05 March 2024** at the Jaffna International Airport, Sri Lanka. The Pre-Proposal meeting will be followed by a Site Visit. The meeting will also be connected through ZOOM and the connection details will be provided to Proponents who have purchased the EOI document.
